Terms and Conditions

- All persons must sign a “Release of Liability” agreement prior to obtaining their pass.
- Season passes remain the property of Hidden Valley Highlands Ski Area Inc. and may be revoked for misuse or violation of the “Alpine Responsibility Code”. Use of this pass by anyone other than the registered pass holder, or alterations to the pass, will result in cancellation of that pass.
- Season passes are not transferable. HVHSA may request identification to verify its validity.
- Season passes are refundable for medical reasons only. Refunds will be granted as follows: up to Dec. 15 – 100 %, up to Jan. 1 – 50 %, up to Feb. 29 – 25 %, after March 1 – no refund.
- A \$ 25.00 processing fee will be charged for replacing lost passes.
- Members **must have** their passes on them at all times to have access to the lifts.
- All age category cut-off dates are **December 31st, 2011.**
- **All applications (including mail in applications) must include payment details.**

Options are as follows:

- **Monthly payment plan – The completed application form AND the application for the monthly payment plan must be completed and received by the HVHSA before July 15, 2011. Note that this years payments will be processed on the 15th of the month.**
- **Regular payment schedules – all applications must include payment either in full or post dated to the discount period date.**

All mail-in applications must include completed “Release of Liability” forms. Applications must be postmarked prior to the discount dates.
