Never-Ever: Unable to stop or turn, no experience with chairlifts.

Beginner: Limited experience on lifts. Skiers are beginning to perform basic wedge turns and stop with some success; snowboarders can side-slip and are beginning to turn on both heel-side and toe-side.

Novice: Little or no assistance required on lifts. Skiers are comfortable and in control with basic wedge turns on green and blue slopes. Snowboarders can link heel-side and toe-side turns on green and most blue slopes.

Intermediate: Skiers can perform parallel turns on Blue slopes and are starting to ski more challenging Black slopes. Snowboarders can link Intermediate Sliding Turns on Blue terrain.

Advanced: Skiers and snowboarders have mastered all terrain including short radius and in bumps.

Note to Parents & Students: Inherent Risk
