Ability Classification

Never-ever: Unable to stop or turn, no experience with chairlifts.

Beginner: Limited experience on lifts. Skiers are beginning to perform basic wedge turns and stop with some success; snowboarders can slide-slip and are beginning to turn on both heel-side and toe-side.

Novice: Little or no assistance required on lifts. Skiers are comfortable and in control with basic wedge turns on green and blue slopes. Snowboarders can link heel-side and toe-side turns on green and most blue slopes.

Intermediate: Skiers can perform parallel turns on blue slopes and are starting to ski more challenging black slopes. Snowboarders can link intermediate sliding turns on blue terrain.

Advanced: Skiers and snowboarders have mastered all terrain including short radius and in bumps.

Note to Participants: Inherent Risk

Skiing/Snowboarding/Other is a sport with physical demands and inherent risks, which are beyond the control of **Hidden Valley Highlands Ski Area Inc. and Hidden Valley Snow School**. Falls, collisions and other incidents may occur and cause injury. Participants will assume all inherent risks of the sport. Following all rules and procedures can reduce the risk of injury. Failure to follow rules will result in the student losing their lift ticket and future resort privileges.

Skiers/Snowboarders Responsibility Code:

Lift ticket holders must always be in control and able to stop and change direction to avoid collisions with people or objects. Hidden Valley Highland Ski Area Inc.
